WHEREAS, Azerbaijan wishes to have the Provider performing the services hereinafter referred to, and

WHEREAS, the Provider is willing to perform these services;

NOW THEREFORE the Parties hereby agree as follows:

**Additional Services**

The Provider shall advise Azerbaijan on its online engagement ("the Additional Services").

**Payment**


Azerbaijan shall pay the Provider an additional fee of ten thousand dollars (US \$10,000), plus expenses, for the Additional Services.
