Subject: Azerbaijan - Unintended Implications of Attending NK Event

Hope my note finds you well.

I am writing to draw your attention to the letter below from the Azerbaijani Ambassador to the United States, Elin Suleymanov, regarding an event scheduled to take place on December 6, 2016, to celebrate the so-called "Nagorno Karabakh Republic." We strongly urge you, your boss, and others from your office not to attend the event in question.

However unintended, attendance at the event would lend legitimacy to an entity that is not recognized by the United States – and would undermine the ongoing peace negotiations between Azerbaijan and Armenia.

The official position of the U.S. Department of State is that "The United States does not recognize Nagorno-Karabakh as an independent country, and its leadership is not recognized internationally or by the United States." This is consistent with the position of previous administrations, both Republican and Democratic. Attendance at this event is not in the best interest of the United States and only threatens to diminish the United States' role in the Minsk Group process.

Further, attendance at the event could be misinterpreted as being supportive of the Russian military buildup in the region. As you may know, Armenia, which supports separatists in the Nagorno-Karabakh region, currently hosts Russian troops and advanced military hardware within its borders. In September, Armenia publicly paraded its new purchase of state-of-the-art Russian Iskander-M missiles, which have the range and capability to threaten international assets in the region.

Dear Representative Chabot,

I am writing to express my utmost concern regarding an event scheduled for December 6, 2016, on the grounds of the U.S. Capitol, to promote a separatist and unrecognized entity illegally established in the occupied territories of Azerbaijan.

Accordingly, I would like to draw your attention to the fact that what some refer to as "the Nagorno-Karabakh Republic" is an illegal entity created by Armenia within the occupied territories of Azerbaijan. The United States along with other OSCE Minsk Group Co-Chairs reiterated in their numerous statements that "Nagorno-Karabakh is not recognized as an independent and sovereign state by any of their three countries, or by any other country." In fact, the separatist entity is not even recognized by Armenia. In addition, the U.S. Department of States has repeatedly expressed that the United States supports the territorial integrity of Azerbaijan.

It is also noteworthy that on June 16, 2015, the European Court of Human Rights (ECHR) ruled that Armenia exercises effective control in the occupied territories of Azerbaijan, which includes the Nagorno-Karabakh region and seven adjacent districts. With this judgment, the ECHR effectively put an end to Armenia's persistent denial of its responsibility for the unlawful occupation of, and military presence in, the territories of Azerbaijan.

Further, four standing United Nations Security Council resolutions currently call for the immediate, complete and unconditional withdrawal of the occupying forces from all occupied regions of Azerbaijan. These resolutions, which were passed following the armed occupation of the Azerbaijani territories by Armenia, reaffirm the sovereignty and territorial integrity of the Republic of Azerbaijan. Unfortunately, these resolutions remain unimplemented in an obvious violation of international law.

Given the level of strategic partnership between the United States and Azerbaijan, I strongly believe that our bilateral relations deserve broad-based support from Congress. Azerbaijan provides multi-faceted support for United States operations in Afghanistan as it previously did in Iraq and the Balkans. Our two nations intensively cooperate on counterterrorism and nonproliferation issues. Moreover, Azerbaijan closely cooperates with the United States on strategic energy issues and greatly contributes to energy security of American allies in Europe and Israel.

This event contradicts the spirit of this strong U.S. - Azerbaijan partnership. Attendance of this event by Members of Congress and their staff may be qualified as support for the separatist regime and would negatively affect the role of an honest broker for the United States, a Co-Chair of the OSCE Minsk Group tasked with facilitating negotiations to find a just and peaceful solution to the conflict. Given the unequivocal U.S. position on territorial integrity of Ukraine, it is important to maintain a consistent policy towards all separatist entities established to undermine the sovereignty and independence of America's partners in the region. Anything less would amount to double standards and set a dangerous precedent of an ambivalent U.S. approach towards separatism, a major challenge also faced by Georgia and Moldova.

It is a time to demonstrate a clear commitment to the peace negotiations. As it has been reiterated on a number of occasions by the OSCE Minsk Group Co-Chair countries, including the United States, the current status quo is unacceptable. Promoting or attending this event is equal to doing just the opposite by helping to consolidate the occupation of Azerbaijani territories and to prevent return of the displaced Azerbaijani population to their homes and properties from which they were forcibly expelled as well as to prolong the protracted conflict that has been detrimental to both Armenia and Azerbaijan. The flare up of hostilities in April of 2016 once again demonstrated the danger posed by the protracted nature of the conflict. Events like the one planned by separatists on December 6 are detrimental for the much needed progress in the negotiations and undermine U.S. mediator's efforts to promote peace.

I urge you and your staff to refrain from participating in this event that is directed against the sovereignty and territorial integrity of the Republic of Azerbaijan and undermines the ongoing peace negotiations. I also hope that there will be an opportunity for the Embassy staff to visit your office to present Azerbaijan's perspective on these issues.
