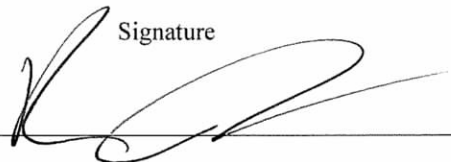

Re: Amendment to Engagement

Dear Ali:

This letter serves as an amendment to the March 26, 2026 engagement between Qatar Foundation (the "Foundation") and Venable LLP ("Venable") (the "Engagement"). The terms of this amendment are effective upon signing.

The Foundation and Venable agree to amend the Engagement as follows:

1. **Scope of Work.** The Third paragraph, beginning "Venable will provide..." is deleted and replaced with the following paragraph:

Scope of Work: Venable will provide government relations services for Qatar Foundation with regard to issues pertaining to the public profile of the Qatar Foundation within the U.S. To that end, Venable will support Qatar Foundation's communications and engagement with state and federal officials to help ensure that members of Congress and the administration, as well as state and local leaders, have an accurate understanding of Qatar Foundations support for education and its work with U.S. universities.

2. **Compensation.** The fifth paragraph, beginning "The Foundation has agreed to pay..." is deleted and replaced with the following paragraph:

Compensation: The Foundation has agreed to pay a fixed-fee of forty thousand dollars (\$40,000) per month starting on July 1, 2026. Venable may retain one or more one firms to assist with its work, subject to the Foundation's prior written approval. The fees and expenses of any approved subcontractor will be in addition to the fixed fee payable to Venable under the Engagement. Venable will invoice you at the beginning of each month for the services provided in that month. We will invoice for expenses incurred (such as travel) in the month following. We will establish the timing of any subcontractor fee payments based on the contracts signed with those vendors.
