The filing, labelling and reporting requirements of the Act were upon the initial determination of Registrant held to be inapplicable in regard to the material indicated in Items 11 (a) and 11 (b), inasmuch as none of this material contains political propaganda within the meaning of Section 1 (j) of the Act.
