After the termination of the registrant's engagement with Monitor Company Group LP ("Monitor") to serve as a subcontractor to Monitor on behalf of the foreign principal, the registrant undertook two subsequent short-term assignments for the foreign principal. Neither was the subject of a written agreement. The first assignment ran from July 1, 2007 - July 31, 2007, and involved arranging interviews of a Libyan official with the foreign bureaus of U.S. media outlets regarding HIV-positive children in Libya. The registrant received a one-time payment of \$60,000 USD for this project. The second assignment ran from September - December 2007, and involved publicizing a Libyan official's visit to France and Portugal. This assignment involved outreach to foreign media outlets and distribution of a press release. The registrant was to be paid a one-time fee for this work, but was never paid

8. Describe fully the activities the registrant engages in or proposes to engage in on behalf of the above foreign principal.

The registrant provided public relations and media services to the foreign principal.

The registrant's public relations activities included outreach to the foreign bureaus of U.S. media outlets regarding interviews with a Libyan official. Additionally, the registrant distributed a press release via Business Wire's Global circuit regarding a Libyan official's visit to France and Portugal.
