- 1. Provided legal advice on possible techniques to obtain debt forgiveness from external creditors for Sudan. I met in Dubai on February 25, 2017, and February 26, 2017, with Jon Cimino, Chairman, The Dubai Group, regarding debt relief for Sudan and possible rescheduling of the foreign debt of Sudan;**
- 2. Advised Sudan on a strategy to present a legal challenge to the U.S. sanctions regime against Sudan and the U.S. Department of State listing of Sudan as a State Sponsor of Terrorism.**
- 3. Worked with the Embassy of Sudan in making arrangements for a trip to Sudan by Carlo Munoz, National Security Correspondent for The Washington Times.**
- 4. Advised Sudan on the application of the Sudanese Sanctions Regulations to contacts with think tanks such as the Cato Institute, the Osgood Center for International Studies, and The Brookings Institution. Briefed Doug Bandow, Senior Fellow, Cato Institute, on January 14, 2017, on the relief from OFAC sanctions announced on January 13, 2017.**
- 5. Attended meeting at the Embassy of Sudan on February 6, 2017, with Peter Watson, Chairman of the Dwight Group, regarding debt relief for Sudan and developing the energy industry of Sudan.**
