**1.0 NATURE AND SCOPE OF THE ASSIGNMENT**

**1.1 The Assignment**

Hassan Ali Bin Ali hereby grants to the Consultant and the Consultant undertakes the assignment to perform consultancy and representation services in accordance with the discussion between the Consultant and Hassan Ali Bin Ali.

The Consultant will represent Hassan Ali Bin Ali pertaining to arranging and coordinating meetings on Capitol Hill, Washington, DC.

The Friedlander group will:

- Arrange Meetings with different members of Congress- on scheduled in advance bi— monthly meetings to discuss bi-lateral relations between the United States and countries across the Middle East and on efforts how to achieve peace and regional stability.
- **A luncheon or reception will be hosted every six months in congress; once in the Senate and the other in the House to allow members of both chambers to meet Hassan Ali Bin Ali in a social setting. It will be scheduled 3 months in advance. Congressional staff, Jewish leaders & diplomats will be encouraged to participate to discuss relevant legislative issues that Congress is in the midst of working on.**

**3.0 DURATION AND COMPENSATION**

**3.1 Duration**

This Agreement is effective from the date of signing of this Agreement for 12 months.

**3.2 Consultancy fee**

The total value of this contract is \$200,000.00. Hassan Ali Bin Ali agrees to pay the Consultant on a quarterly basis of \$USD 50,000.00.

Should any of the parties decide to terminate the contract, 30 days advance notice will be required.

5.0 CONFIDENTIALITY

The Consultant agrees and undertakes that he will not use or reveal to any third parties confidential information regarding Hassan Ali Bin Ali.

6.0 COMPLIANCE AND REPORTING

The Consultant will ensure compliance with committee rules and guidelines governing lobbying and disclosure laws.

The Consultant will register this contract by U.S. Justice Department.

7.0 FORCE MAJEURE

A party is relieved from liability for a failure to perform an obligation pursuant to this Agreement if the failure to perform is caused by a circumstance beyond the party's control and which the party responsibly should have not foreseen and which prevents the party's performance of its obligation pursuant to this Agreement. As soon as the obstacle has terminated, the obligation shall be performed in the contracted manner.


