In the last six months, Mr. Torricelli has engaged in facilitating the movement of Iranian refugees from the former U.S. military facility at Camp Liberty in Baghdad, Iraq to housing in Albania provided by the UNHCR, the UN Refugee Agency, under the auspices of the U.S. State Dept. Mr. Torricelli's efforts included working with the U.S. State Dept. to arrange safe transportation and assist the U.S. State Dept. and the foreign principal, NCRI, in making arrangements with the government of Albania for the refugees' accommodations. In the furtherance of the objectives, Mr. Torricelli worked closely with U.S. Secretary of State Kerry's Special Representative to the NCRI, Jonathan Winer, and his staff; officials of the UNHCR; and NCRI. The specific contacts with U.S. officials are detailed in Attachment One.
