

Moneys received by Mr. Torricelli are determined by taking Rosemont's income during the period and determining what percentage of that income is derived from service to NCRI. That same percentage is then applied to his individual receipts during the period to yield a percentage representing that amount of receipts attributable to work for NCRI. Beginning in 2018, payments to Mr. Torricelli were changed from regular salary payments to unscheduled lump sum payments.
