

THIS RIDER is attached to and made a part of the contract dated July 11, 2023 between the Government of the Republic of Serbia, and KARV Communications.

NOW, THEREFORE, in consideration of the mutual obligation in the contract, the Parties agree to the following rider agreement:

1. Scope of Work – KARV will continue working with you and other members of the Government of the Republic of Serbia.
2. Term of Engagement is amended to provide that the agreement shall be for 1 year from July 15, 2024 through July 14, 2025.
3. Compensation and Billing is a fee of \$60,000 per month.

All other terms and conditions of the Agreement shall remain in full force and effect.
