The Registrant will serve as the political representative of the Foreign Principal in the United States. The Registrant is a US non-profit entity. The Principal appoints the Chair of the Registrant, in accordance with the Registrant's Bylaws. There is no formal financial agreement between the Registrant and the Principal. The Foreign Principal may transfer funds to the Registrant to be used for the Registrant's expenses in the US, such as salaries, office expenses, vendor fees, travel, and related expenses. Any funds will be used exclusively for non-profit purposes in accordance with the Registrant's organizational documents, policies, and applicable law.

8. Describe fully the activities the registrant engages in or proposes to engage in on behalf of the above foreign principal.

The Foreign Principal has been recognized by the US Government as the legitimate representative of the Syrian people. The Registrant will serve as the political representative of the Foreign Principal in the United States. The Registrant may meet with US and foreign officials, legislators, ambassadors, and others in order to advocate for the provision of urgently needed aid and support for the Syrian people, and the establishment of peace, freedom, and democracy in Syria. The Registrant may also engage with the Syrian American community on related issues. The Registrant may also seek to engage with the media and the US public directly. The Registrant may also reach out to humanitarian assistance organizations, human rights groups, think tanks, and other interested parties in order to build support for peace, freedom, and democracy in Syria.
