This refers to the Consulting Services Agreement (the "Agreement") between the Embassy of the State of Qatar and Mercury Public Affairs LLC ("Mercury"), effective January 1, 2015, as amended.

This will confirm our mutual agreement to extend the Term of the Agreement for the period commencing July 1, 2018 and expiring on June 30, 2019.

The fee shall be \$120,000 per month, payable monthly on the first day of each calendar month, commencing July 1, 2018. Expenses in excess of \$1,000 per month shall not be reimbursed unless Mercury receives written approval from the undersigned representative of the State of Qatar prior to incurring such expenses.

During the Term, and for a period of one year thereafter, neither Mercury nor any employee or subcontractor assigned by Mercury to work on this Agreement, shall advise, represent or accept engagements from any sovereign state whose Ambassador is recalled from Qatar as of July 1, 2018, or any entity that is substantially owned or controlled by such states.


The Embassy has assigned this Agreement to the Government Communications Office of the State of Qatar, and Mercury consents to such assignment.

Except as expressly stated herein, nothing in this letter shall alter or amend the terms of the Agreement, as amended. Without limiting the generality of the foregoing, the parties reserve their respective rights under Paragraph 3 of the Agreement to terminate the Agreement without cause at any time, effective 30 days after written notice.
