



Re: Engagement Letter for Lobbying Services

Dear Bryan:

This letter (“Agreement”) describes the terms on which Mercury Public Affairs LLC (“**Mercury**” or “**you**”) has agreed to provide lobbying services (“Services”) to OB Projects Management CC (“**OB Projects**” or “**we**”).

Description of Engagement (“Project”)

You have been engaged by OB Projects to lobby on behalf of the Commercial Farmers Union of Zimbabwe (“CFU”), Southern African Commercial Farmers Alliance-Zimbabwe (“SACFA”), the Valuation Consortium (Private) Ltd. (“Valcom”), and the Property and Farm Compensation Association (“PROFCA”) (collectively the “Farmers Unions”) regarding their Project to obtain full compensation for Zimbabwean farmers in accordance with the terms of the Global Compensation Deed entered into by the Republic of Zimbabwe on July 29, 2020 (“Deed”). Specifically, the Services you will provide include contacting appropriate officials in the current Administration and Congress to promote paying the Zimbabwean farmers the remaining balance of USD 3.5 billion owed under the Deed through new financing from the International Financial Institutions (“IFIs”), including the World Bank. The Project envisions an arrangement in which the U.S. Government supports the clearance of the Zimbabwe Government’s debt and the creation of new financing arrangements at the IFIs that will generate the funds necessary to satisfy the Zimbabwe Government’s debt to the farmers.

Description of Basis for Fees

You have agreed to provide your lobbying services and any expenses on a pro-bono basis.

Public Disclosure

You understand that before you can provide these Services, you will be required to publicly register your company as a foreign agent of OB Projects Management CC pursuant to the Foreign Agent’s Registration Act.

Independent Contractor

Mercury is an independent contractor to whom OB Projects has no obligation as an employer. Mercury shall pay its own expenses, including but not limited to all salaries of Mercury's employees, occupational taxes in the form of licenses to engage in or to conduct business, and all taxes including that may be assessed on the personal property and equipment of Mercury used in the conduct of Mercury's business.

Termination

This Agreement is automatically terminated upon the successful completion of Services provided by you. This Agreement may also be terminated by the mutual consent of the Parties. No part of this Agreement may continue past the expiration of this Agreement. All materials generated by OB Projects or created by you under this Agreement shall remain the property of OB Management.

Governing Law, Jurisdiction and Venue

This Engagement Letter shall be governed by and construed and enforced in accordance with the laws of the State of New York, without regard to conflicts of laws principles. Exclusive jurisdiction over and venue of any suit arising out of or relating to this Agreement will be in any district court of the State of New York and each party hereby submits to the jurisdiction of such courts in connection with any suit arising out of or relating to this Letter Agreement. In the event of any litigation arising from or related to this Letter Agreement the prevailing party shall be entitled to recover from the non-prevailing party all reasonable costs incurred including court costs, attorneys' fees, and all other related expenses incurred in such litigation.

Indemnification, Supersession, Amendment, Effective Date

Each Party agrees to indemnify the opposite party for any acts taken in breach of this agreement. This Agreement constitutes the entire and only understanding between the Parties, and supersedes all prior writings or discussions with respect to the subject matter herein, and specifically excludes any services not listed above unless adopted by amendment. This Agreement may be amended or modified only by a written agreement signed by an authorized representative of each party hereto. Notwithstanding the dates written above or below, this Agreement shall not become effective before December 22, 2025.
