

**CONSULTING SERVICES AGREEMENT  
AMENDMENT**

**THIS AMENDMENT**, effective January 1, 2026, shall amend that certain Consulting Services Agreement dated January 1, 2020, as amended (the "Agreement"), by and between:

**Mercury Public Affairs, LLC** (the "Consultant")

In consideration of the mutual promises set forth herein, the Embassy and Consultant agree to amend the Agreement as follows:

1. The Term of the Agreement shall be renewed for the period from January 1, 2026 through December 31, 2026 (the "Renewal Term"), unless earlier terminated in accordance with the Agreement. The Term may be extended only upon execution of a written amendment, signed by authorized representatives of both parties.
2. During the Renewal Term, the Consulting Fee shall be governed by the following:

**"Consulting Fee:** For the Services rendered pursuant to this Agreement, Embassy shall compensate Consultant as follows: **US\$ 32,500.** per calendar month (the "Consulting Fee"). Payments shall be made on the last calendar day of each month during the Term."

Except as expressly stated herein, nothing in this Amendment shall alter or amend the terms of the Agreement.
