Hi Jim,

I hope you've been well since the last time we connected last month. Would you be interested in speaking with Haiti's Elections Minister Mathias Pierre on efforts around the referendum in June and elections in the Fall?

Minister Pierre can also shed light on how the government is overcoming the challenges of getting ID cards into the hands of 2.5 million voters, especially for those who don't have a birth certificate or other proof of identification (4 million voters already have ID cards); working with Haiti's National Police (not MINUSTAH) which is providing security for this election; and consolidating Haiti's 253 political parties.

If you're interested, I can coordinate the interviews via Zoom and Skype. Thanks in advance for your consideration, Jim.
