The registrant has provided advice to the FP on attracting investment from the U.S. The registrant has also disseminated investment, tourism, economic and other materials in support of investment and business discussions with U.S. firms and funds. The registrant has in public and private meetings conveyed information on behalf of the FP to the U.S. Administration and Congress related to mutual interests and concerns of both parties.
