DuSable Capital Management, LLC (DuSable) will be the investment adviser to a private equity fund in which 1Malaysia Development Berhad (1MDB), the Government of Malaysia's development fund, will be a limited partner. The private equity fund and 1MDB are working together jointly to invest in a solar energy project in Malaysia. In connection with the investment, 1MDB will reimburse costs incurred by DuSable arising out of the development of the project and associated activities. While the bulk of DuSable's activities will relate to development of the project, one aspect of DuSable's activities will be to communicate with U.S. government officials to encourage the U.S. government to provide non-financial support for the project. There is no formal agreement specifying such communications or activities.
