Registrant also provides lobbying services to the foreign principal in other countries. The anticipated extension of such activities into the United States is the catalyst for this registration.



CONSULTANCY AGREEMENT

You hereby retain us, and we hereby agree, as more fully set forth below, to lobby the President of the DRC, the executive and/or legislative branches of the governments of the United States, the European Union, Israel, the United Nations, the AU, the CEPGL, the SADC, and any other mutually agreed upon country or countries, international organizations, NGOs, corporate and business interests on your behalf and also to provide other services, all to assist the devising and execution of policies for the beneficial development of your political objectives, as more fully described below, and subject to the terms and conditions set forth below.

1. Our lobbying services shall consist of maintaining such contacts with the President of the DRC and the executive and/or the legislative branches of the aforesaid government or governments, international organizations, NGOs as well as corporate and business interests as you shall, in consultation with us, deem advisable in order to urge the institution and/or maintenance of legislative and/or executive policies favorable to you, and the elimination or prevention of such policies unfavorable to you. In particular, we shall strive, among other goals, to conduct lobbying, in the aforesaid countries, and organizations in order to obtain a general consensus and approval for a new provisional government for the Democratic Republic of the Congo to assume power in January of 2018 for a period of two years in order to assure stability and a smooth transition of power through presidential and parliamentary elections to be held in January of 2020. The provisional government shall be headed by yourself as President and the current President of the DRC, HE Joseph Kabila who will assume the office of Prime Minister. The existing elected representatives and officials shall remain in power for the two-year period of the provincial government's rule to assure stability. All members of the provisional government (executive and legislative) will be able to run for office in the elections to be held in 2020 unless they have already served the time

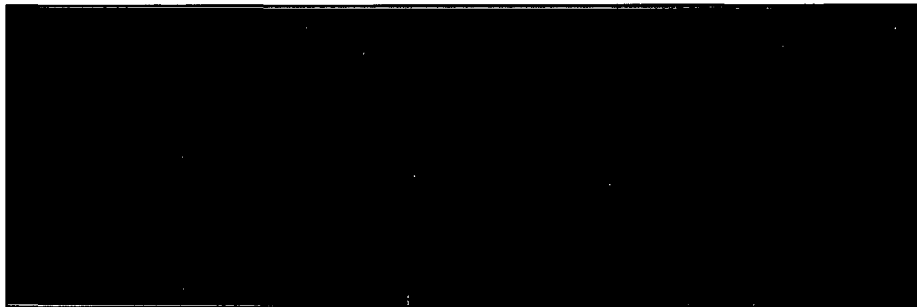

allowed by the constitution. After reaching an agreement between yourself and HE Joseph Kabila, we shall strive to arrange a meeting with yourself, HE Joseph Kabila and the Honorable Donald Trump. Consequently, we shall also strive to arrange meetings between yourselves and heads of governments of other members of the UN Security Council.

2. The lobbying services noted above shall be conducted by us if and only to the extent they are mutually agreed upon, and only to the extent allowed by law and in particular, but without limitation, only to the extent that all activities conducted by us can be, and are, in compliance with any and all laws and regulations relating to lobbying on behalf of a foreign entity, including registration and disclosure. As you know consultants are not allowed to receive any funds that devolve from government grants that they may procure for their client.

3. The other services cited by us above shall, to the extent mutually agreed upon, include assistance in providing media and public relations assistance in establishing a favorable international opinion of the new provisional government, its structure and personalities.

4. The fee for this consultancy agreement shall be US\$2,000,000.00 payable upon signature of this agreement by wire transfer to the following account:



5. Any normal out-of-pocket disbursements shall be our responsibility; and the payment of any unusual out-of-pocket disbursements shall be as mutually agreed upon.

6. We will keep you fully advised on all our efforts on your behalf.

7. We shall develop a series of guidelines within which we shall have the discretion to act on your behalf, subject always to your specific instructions.

8. We shall exert reasonable efforts to secure favorable legislative and/or executive policies, including, without limitation, the specific items noted in paragraph 1 above. You are aware, however, that it is not possible in these fields to guarantee any particular results. In order to enable us to serve your interests effectively, considering the foregoing, you agree to cooperate with us fully in furnishing us with necessary information as promptly as possible.

9. The term of this agreement shall be for two years, renewable upon mutual agreement.

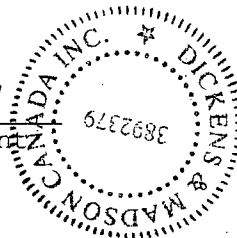
10. This letter of agreement sets forth our entire understanding.
