11. During the 6-month reporting period Dickens & Madson provided the following services to each of the foreign principals listed below:

With respect to the Union of Myanmar, Dickens & Madson's contract with Myanmar was cancelled by the registrant before the conditions for its effectiveness were satisfied.

With respect to Progressive Advance, Dickens & Madson continues to attempt to broker a compromise with respect to the control of government in Venezuela but has not engaged in activity with respect to the United States toward that end in the registration period.

With respect to Republic of Congo and Prof. Mboyo-Di-Tampa Vangu, Dickens & Madson has continued its work to reduce and remove the influence of the former president. Dickens & Madson has not engaged in activity with respect to the United States during the reporting period.

With respect to the Sovereign Council of Sudan, Dickens & Madson continues to consult with the Sovereign Council of Sudan with respect to the transition to a fully civilian government but has not engaged in activity with respect to the United States during the reporting period.

As to Christopher Siriosi (Bougainville), Dickens & Madson continues to pursue the efforts aimed at political and economic support with respect to Bougainville independence but has not engaged in activity in the United States toward that end in the registration period.

Regarding West Papua, although the consultancy agreement between Dickens & Madson and the foreign principal expired in October 2018, the Registrant continued to provide occasional support outside the United States and there were a few communications with officials of the foreign principal through September 2019. The individual who signed the previous agreement died in February 2020; it is anticipated a new agreement will be executed. The Registrant will then file an Amendment to Exhibit B.

As to the Republic of Vanuatu, Dickens & Madson's activities on behalf of the Republic of Vanuatu were suspended during the reporting period but are expected to recommence in August 2021.

With respect to DPWORLD FZE, Dickens & Madson's efforts to facilitate an arrangement for the operation of Port Sudan by the foreign principal have continued during the reporting period but did not include any activities with respect to the United States.

With respect to the Kyrgyz Republic, Dickens & Madson is awaiting instructions from the foreign principal with respect to its activities and has engaged in no activities during the reporting period.
