Republic of Srpska: In the context of representing Republic of Srpska and its goal of obtaining independence from Bosnia Herzegovina, D&M held several engagements with the Office of the Crown Prince of Saudi Arabia and the Office of the President of Israel.

Both foreign governments have close relations with Republic of Srpska and Bosnia Herzegovina, and have an interest in Republic of Srpska's independence.

During these engagements, D&M understood that each foreign government planned to subsequently present this issue to the US government. D&M was not privy to the engagements between these foreign governments and the US government, and is therefore unable to provide details about those engagements, including when they occurred and with whom they occurred.
