SERVICES AGREEMENT

This agreement is made between Mr. Ayman Asfari "Client" and LB International Solutions, "LBIS".

1. **Term:** The term will be for six months, starting November 1, 2017 and ending on April 30, 2018.
2. **Services:** LBIS is to provide lobbying and consulting services for the Client with the United States Congress.
3. **Personnel and Other Service Providers:** LBIS will compose its own team to achieve best possible results in providing consulting services to Client.
4. **Fees:** Client agrees to pay LBIS \$12,500/month at the beginning of each month by wire transfer, commencing at the signing of the contract.
5. **Termination:** Either party may terminate this Agreement at any time prior to its natural expiration with a 15 day advance written notice. In this event, Client shall pay LBIS its pro-rata share of earned fees apportioned on a daily basis through the end of the notice period. Should the Agreement end prior to its natural expiration, any fees paid by Client to LBIS shall be refunded on a pro rata basis up to the date of termination.
6. **Reporting:** LBIS will provide a report every two months describing its work and accomplishments on Client's behalf.
7. **Registration and Disclosure:** LBIS will comply with any and all restrictions and requirements, including filings and other disclosures, of the Lobbying Act or Foreign Agents Registrations Act, as required.
8. **Choice of Law:** This Agreement will be governed by, and construed in accordance with the laws of the District of Columbia.
