PROPOSED ACTIVITY AND STATEMENT OF WORK:**FY25 INFLUENCER PROGRAM**

Work with Travel Alberta to negotiate and facilitate two hosted influencer trips this fiscal year.

Activity:

This end-to-end influencer program will bring two creators to Alberta for immersive, in-person winter experiences that showcase the province's cold weather offerings.

- Vet influencers to host, based on:
 - Content alignment
 - Relevant past brand/destination partnerships
 - Audience (reach/demographics)
 - Engagement rates by channel
- Once targets are approved, approach priority influencers to determine engagement rates and availability for travel between mid-November and mid-February
- All influencer negotiations, including rates and deliverables.
- Contracting. FINN will develop and draft contract agreements based on agreed-upon deliverables. Travel Alberta will pay influencers directly.
- Itinerary development, in partnership with Travel Alberta .
- Review and approval of content deliverables.
- Ensuring influencers are staying on track within agreed-upon timelines.
- All communication with the influencer, including around contracting, itinerary, content.

- Reporting, inclusive of influencer-provided engagement rates, screen grabs of still images, and a file with screen records of dynamic content that won't stay live (ie stories).

BUDGET AND FEE PAYMENT SCHEDULE

A budget of \$15,000 USD has been designated for the project period. The fee will be invoiced in one installment, immediately upon execution of this Service Request.

The fee does not include any expenses related to the influencer's engagement rates or travel. These expenses will be paid by Travel Alberta directly. Any other related expenses will be approved by Travel Alberta in writing ahead of expenditures.
