Dear Ms. Santopietro:

This refers to the Standard Contract (the "Agreement") between the Embassy of the State of Qatar and Levick Strategic Communications, I.L.C, effective January 1, 2015, as amended.

This will confirm our mutual agreement to extend the Term of the Agreement for the period commencing January 1, 2017 and expiring on March 31, 2017.

The Fees payable to Levick during the period January 1 through March 31, 2017 shall be \$54,000 per month, payable monthly on January 1, February 1, and March 1, 2017. Expenses in excess of \$1,000 per month shall not be reimbursed unless Levick receives written approval from the Embassy prior to incurring such expenses.

Except as expressly stated herein, nothing in this letter shall alter or amend the terms of the Agreement, as amended. Without limiting the generality of the foregoing, the parties reserve their respective rights under the Agreement to terminate the Agreement without cause at any time, effective 30 days after written notice.
