As noted in the original registration (30 Dec. 2014) three foreign embassies – the Embassy of the Republic of Lithuania, the Embassy of the Republic of Croatia, and the Embassy of the Czech Republic – are currently members of the LNG Allies "Council of Embassies" and act as informal advisors. However: (1) LNG Allies acts on behalf of its membership as a whole, and is not directed or controlled by any single member (foreign or domestic); and (2) none of the three embassies listed above (or their governments) supervise, own, direct, control, finance, or subsidize the corporation.
