Question 11: The registrant performed no activity covered by the Act for the China Rilin Industrial Group through China / US Club, LLC, despite its anticipation of such activity at the time of registration, during the reporting period.

For the registrant's other foreign principal client, The People's Republic of China, the registrant's personnel made contact with three U.S. Senators as described in the response to Question 12, below. The April 28 meeting involved no discussion of any political subject; this was strictly a nonpolitical contact; the registrant is disclosing it here in and in Question 12 from an excess of caution. The May 1 and 2 meetings did involve political activity, introducing the Chinese Ambassador to Senators McCain and Hatch; Ambassador Cui Tiankai invited the Senators to visit China at some unspecified future date.

Question 15(a): The Rogich Communications Group made, and distributed, no disbursement on behalf of either of its current foreign principal clients, The People's Republic of China and the China Rilin Industrial Group through China / US Club, LLC, during the reporting period. The registrant's low level of activity during the period on behalf of these clients explains the lack of disbursement.

The registrant's response, above, to Question 11, details three meetings in Washington, DC arranged on behalf of the People's Republic of China. Because the registrant's personnel travelled to Washington, DC for other purposes not subject to the Act (i.e., specifically, on behalf of other clients), no portion of the travel-related expenses incurred for these other clients' benefit is attributable to the registrant's foreign agent clients, The People's Republic of China and the China Rilin Industrial Group through China / US Club, LLC, as a "disbursement."
