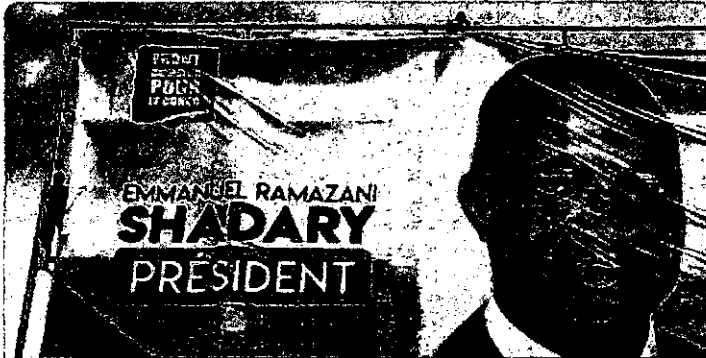

Statement of the Predisposition of the Democratic Republic of Congo 01/19/2019

My Fellow Congolese,

In its decision rendered public this night of January 19, 2019, the Constitutional Court just validated the false provisional results of the Presidental election of December 31st which was published at night in flagrant violation of the electoral law by the Independent National Electoral Commission, CENI.

With this decision, the Court showed once more, that similarly to CENI, it is at the service of one individual and of a debatable regime that doesn't respect the law of the People and the usual elementary rules of Democracy and morality.

In defining the Congolese people, the African Union is the entire International Community

As a matter of fact, it is not a secret for anyone inside and outside the country that you have elected me as President of the Democratic Republic of Congo with over 61% of the votes. This landslide victory was confirmed by tally sheets from witnesses of the Lamuka coalition. It concerned reports from both national and international electoral observing missions including CISAID (Catholic Church), the African Union and tables of results from the central server of the Independent National Electoral Commission (CENI) published by international media.

The CENI and the Electoral Court hid their face and then concealed the truth of the ballot to serve an unjust cause and maintain a regime rejected by the people. It is nothing more than a constitutional coup as it entails a non-elected individual to the highest office.

This is why, in accordance with article 5 of the Constitution (the latter states that the National sovereignty belongs to the people, all powers emanate from the people who exercise it directly through referendum or election), I am now considering myself as the sole legitimate President of the Democratic Republic of Congo.

As such, I ask the Congolese people not to recognize any individual who would claim his authority illegitimately nor to obey any orders that would emanate from such a person.

I also ask the international Community not to recognize a regime that has no legislative nor legal quality to represent the Congolese people.

Follow citizens,

As of now, I am making a pressing call on our people to face its destiny in its hands by organizing peace and demonstration across the country in order to defend its sovereignty in conformity with the article 64 of our Constitution which obligates us to defend it in life and death in addition to the foregoing terms. Every Congolese has the duty to ban any individual or group of individuals that take power by force or exercise it in violation of the stipulations of the current Constitution.
