There is no agreement between Targeted Victory and the Royal Embassy of the Kingdom of Saudi Arabia. There is an oral agreement between Targeted Victory and Qorvis that governs all work provided by Targeted Victory to Qorvis, which includes any and all clients of Qorvis.

The key terms that may extend to the Embassy of the Kingdom of Saudi Arabia are as follows. Until either Targeted Victory or Qorvis wishes to terminate the agreement: Targeted Victory will provide digital consulting services to Qorvis, which includes, but is not limited to, social media content and management, and Targeted Victory will provide analysis on the feedback received from Signal Labs. In consideration of such services, Qorvis shall pay Targeted Victory \$40,000 per month for the consulting services and \$15,000 per month for analysis of Signal Labs.
