**Fees, Terms & Expenses:** In consideration for the services provided by Dentons, KRG agrees to pay a monthly professional fee of USD \$20,000.00 for services beginning January 1, 2018 and ending December 31, 2018. However, this contract is at-will and could be terminated by either party with a 30-day notice.
