5. I met in Khartoum, Sudan, on October 7, 2015, with officials from the Sudan Ministry of Finance's debt relief unit to organize briefing materials on the Sudan debt issue.

- (f) On February 10, 2016, I set up a meeting for Sudan's Ambassador to the United States, Maowia Khalid, with Teresa Walsh, reporter, U.S. News & World Report, regarding Sudan debt relief.
