Registrant paid for multiple trips which he, along with associates, made on various dates to Sri Lanka and within the United States during the relevant time period. These things of value included flights, hotels, ground transportation, food and related travel expenses. Registrant estimates the approximate value of these expenditures to be around \$115,000. The purposes of these expenses were travel-related, and they were expended in furtherance of the interests of the Government of Sri Lanka.
