There is no formal agreement between the Assyrian Democratic Movement and the Nineveh Plain Defense Fund. However, two members of the Assyrian Democratic Movement's leadership in Iraq are board members of the Nineveh Plain Defense Fund. Yacob Yaco is a member of the Assyrian Democratic Movement's Political Bureau, and Susan Patto serves as the Chief of Staff of the Secretary General of the Assyrian Democratic Movement. Yacob Yaco also serves as the Chairman of the Military Committee of the Nineveh Plain Protection Units. The Chairman of the Nineveh Plain Protection Units Military Committee is an ex officio board member of the NPDP with special powers, including the approval of nominations of board members and the power to veto decisions of the NPDP board. Two additional NPDP board members are active members in American chapters of the Assyrian Democratic Movement: Alexander David and Salam Yaldiko.

8. Describe fully the activities the registrant engages in or proposes to engage in on behalf of the above foreign principal.

The Nineveh Plain Defense Fund is to be organized as a nonprofit corporation of the State of Illinois with the goal to direct support from Americans and others throughout the world for the Nineveh Plains Protection Unit of Iraq in full compliance with the laws of the United States. The NPU are a local security force in the Nineveh Plain of Iraq originally sponsored by the Assyrian Democratic Movement and now recognized by the Government of Iraq.


If yes, describe all such political activities indicating, among other things, the relations, interests or policies to be influenced together with the means to be employed to achieve this purpose.

While political lobbying is not the purpose of the Nineveh Plain Defense Fund, the Defense Fund intends to inform the executive administration of the United States and legislative members of Congress of its activities. The Defense Fund does not intend to provide any political contributions but may organize or participate in events in which others may collect contributions for political purposes.

The primary intent of the Nineveh Plain Defense Fund is not to engage in political activity. However, it is possible that in the performance of our mission we interact with officials of the United States Government and influence policies of the United States. The Nineveh Plain Defense Fund is supportive of policies that would provide financial, logistical, and training support directly to the Nineveh Plain Protection Units of Iraq as well as policies that would provide financial, logistical, humanitarian, and economic development support directly to the indigenous ethnoreligious minorities of the Nineveh Plains of Iraq and their non-governmental organizations.
