**Re: Terms of Engagement**

**Dear Mr. Sino and Mr. Baci:**

**We at the Alexandria Group International (the "Firm"), are pleased that you, Top Channel Shareholders Albert Sino and Aurel Baci of Tirana, Albania ("Shareholders Sino and Baci"), have chosen our firm to assist in representing your U.S. and international interests pertaining to your status in the Top Channel company. The purpose of this letter is to confirm the terms of our overall engagement. This engagement is effective August 2, 2016, and will continue in effect as mutually agreed by the Firm and Shareholders Sino and Baci. During our engagement, you agree to pay the Firm a retainer of \$50,000.00, due within thirty days of signing of this agreement. The Firm and Shareholders Sino and Baci agree further that they will negotiate an additional fee for payment due upon successful completion of this agreement. The Firm will bill separately and Shareholders Sino and Baci agree to pay for incidental expenses, including travel expenses, but travel by members of the Firm must be approved in advance by Shareholders Sino and Baci, and Shareholders Sino and Baci must render payment for such expenses in advance of travel.**

**I will actively participate in, supervise, and coordinate our day-to-day work under this agreement. Our team will also include my Firm partners John Menzies and Elmi Berisha. We will meet with you and/or your designated representatives on a regular basis and coordinate with you by telephone as frequently as necessary. The supervision of the engagement shall be under my direct control, and no activity relating to our work on behalf of Shareholders Sino and Baci shall be generated without my or my partners' explicit direction and approval.**

We agree that our activities will focus specially on assisting you with your agenda as it relates to promoting your political and public policy interests regarding your role in the Top Channel company. The Firm and Shareholders Sino and Baci will agree on a work plan to cover these activities. The following activities are among those we are prepared to undertake on Shareholders Sino and Baci's behalf.

- Work to advance Shareholders Sino and Baci's specific goals related to making the company a greater priority in the U.S. Administration's policy agenda.
- Increase exposure of Shareholders Sino and Baci and their issues before the U.S. Administration, Congress, media, and other relevant communities.
- Assist in scheduling meetings for Shareholders Sino and Baci with executives with Administration officials, Republican and Democratic members of the U.S. Senate and U.S. House of Representatives, and other policymakers and opinion-shapers in the United States and beyond.
- Assist in messaging for Shareholders Sino and Baci, including preparing public and private statements.
- Provide analysis of U.S. political, business, and other relevant developments.
- Through close coordination with you and your representatives, we are also prepared to undertake other special assignments on your behalf, provided that they are mutually agreed to by both parties.

As in any professional relationship where mutual trust and confidence are essential, it is appropriate for either Shareholders Sino and Baci or the Firm to be able to terminate our engagement by reasonable notice. If our engagement is terminated, we understand that Shareholders Sino and Baci will take whatever steps are necessary to evidence that we are free from any obligation to perform further, and to pay us for unpaid fees, charges for related expenses, and services incurred to the date of termination. We agree further that this agreement shall not include provision of legal services.

We would appreciate your acknowledging that this letter correctly reflects the terms of our engagement by signing, dating, and returning to me the enclosed copy of this letter. There is space for your acknowledgement below my signature.


