### Contract for Services

**Subject: Advisory Services to Dr. Claude Mawissa, Chairman, DRC Democracy and Development Association (DRCDDA), Democratic Republic of Congo**

McMark, LLC proposes to advise Dr. Mawissa and the DRCDDA in efforts to explore and pursue democratic reform, constitutional discipline, law and order, national security and economic development in the DRC. The next steps in advancing the democratic, economic, security, technology, education and political life of the nation is by assuring that a fair Presidential election is conducted according to the current Constitution. McMark, LLC has the requisite expertise in Washington, DC, major business centers such as New York City, and in European capitals to bring influence and support to the previous accomplishments of Dr. Mawissa and the goals of the DRCDDA.

McMark, LLC can obtain strong praise and recognition as well develop and publicly communicate the future vision of the DRCDDA as it seeks to promote international understanding and political persuasion on the current DRC Government to uphold a democratic republic by conducting fair, free, non-violent elections. Achieving this legacy, announced ahead of any improper elections and communicated with tenacity/strength/sustained focus during a vigorous education campaign will be the mighty protection that surrounds new elections and the new President and his team of officers/Ministers in the years ahead, and it will ensure the international community and DRC public's approval for the current President Kabila to retire from office without the threats that always undercut a would-be dictator.

It is important to provide a legal, dignified way out of office for President's who might choose to stay in office as dictators. Praise for work and sacrifice for the nation are the best reward for a hard-working President and will provide a well-deserved presence on the international stage for President Kabila when he retires according to the Constitution (much like former USA President Bill Clinton, a good President and now a huge kingmaker internationally).
