All work performed by Husch Blackwell LLP attorneys and lobbyists will be compensated on an hourly basis based on the amount of time spent. Husch Blackwell will take direction from the U.S. Ambassador from the Kingdom of Morocco for this engagement.

Husch Blackwell LLP will communicate with Members of Congress, their staff, and appropriate Administration officials on behalf of the Kingdom of Morocco. We will educate these officials about issues and policies that are important to the Kingdom of Morocco while raising its profile generally.
