CCPIT had previously engaged Husch Blackwell in a litigation matter and paid up front a lump sum of money. CCPIT later asked Husch Blackwell to bill hourly against that sum of money for its work on this project. This project will involve educating Members of Congress, their staff, and Administration officials regarding trade issues as they relate to stainless steel.

8. Describe fully the activities the registrant engages in or proposes to engage in on behalf of the above foreign principal.

A delegation of individuals from this group is coming to Washington, DC at the end of January to observe an International Trade Commission (ITC) hearing on January 31st on the importation of stainless steel sheet and strip from China. We will set up meetings for them with Members of Congress or their staff, focusing primarily on the China Caucus, to educate them on issues surrounding the stainless steel trade. We may also ask to see if these Members would be interested in sending a letter to the ITC in attempt to discuss these stainless steel issues.
