

Registrant will assist the Royal Hashemite Court with the draft preparation of various public remarks and written communications for the Office of Her Majesty Queen Rania Al-Abdullah. The remarks are expected to revolve around issues of interest to Her Majesty, such as humanitarian, cultural, cross-cultural, regional development, educational, women's and children's issues, and to be designed to promote awareness of these issues, as well as cross-cultural understanding, tolerance, partnership, and peace.
