

Through an oral agreement, the Trailblazer Group serves as a sub-contractor to Bellwether Strategies, Inc. its representation of the Government of Panama. The Trailblazer Group advises Bellwether Strategies on the communications it distributes on behalf of the Government. The Trailblazer Group has already received \$22,500 and expects to receive an additional \$15,000 for services performed. The arrangement is a five-month agreement with work occurring in 2016.

8. Describe fully the activities the registrant engages in or proposes to engage in on behalf of the above foreign principal.

The Trailblazer Group works as a sub-contractor in advising Bellwether Strategies on the substance and distribution of communications it prepares and disseminates to U.S. persons on behalf of the Republic of Panama (Ministry of Foreign Affairs).
