Used my social media account on Twitter to highlight political, social and economic developments in Saudi Arabia. However, that was not done on behalf of the principle nor was it done in coordination with it.

I wrote an essay entitled "What is at Stake in Yemen" that was published by the Hoover Institute on December 20, 2018. The essay examined the history of political turmoil and economic challenges that have contributed directly to the current crisis in Yemen. I also continued to write a weekly column for the Saudi daily Arab News. Although these activities could potentially benefit the foreign principal, it is important to note that these are the sorts of activities in which I have been engaged as a scholar on Saudi Arabia for many years and prior to my representation of the foreign principle. Just as importantly, my contract explicitly states that I am not authorized to speak on behalf or to represent the foreign principle in anyway. It is also important to note that I mention my consulting relationship with the foreign principle during all my media interviews and speaking engagements at US government agencies, think tanks and academic institutions.
