On October 18, 2012, Republic of Korea purchased a historic legation building in Washington, D.C. The building is located at 1500 13th street, N.W., Washington, D.C. 20005. The management and fiduciary duty of that building was assigned to the Overseas Korean Cultural Heritage Foundation on January 31, 2013, by the Cultural Heritage Administration of South Korean Government. Currently, there is an ongoing construction and renovation effort to restore the legation building and transform it into a Korean Legation Museum. The Museum is anticipated to be open in the Summer/Fall of 2017.
