The registrant completed the project of restoring the Old Korean Legation building purchased by the foreign principal, the Cultural Heritage Administration of the Republic of Korea. The building located on 1500 13th Street, N.W., Washington, D.C. 20005, has been restored as a museum reflecting the original appearance of the diplomatic mission building during its operation in the 19th century. To signal its historical significance, the museum showcases Korean heritage artifacts collected from various places outside the Republic of Korea. On May 22, 2018, the registrant hosted a ceremony celebrating the opening of the museum.

Such activity was for the benefit of the foreign principal in connection with its intended goal of making the Old Korean Legation building a significant historic site, offering cultural awareness of the Korea-U.S. relationship and the heritage of Korea.
