RE: Supplemental Agreement

Dear Mr. Laviv:

This letter is aimed to supplement the working agreement between Mer Security and Communications Systems, Ltd. ("MER") and Sonoran Policy Group, LLC ("SPG").

**It approves a three month "Branding Project" and "Cobalt Reception,"** pursuant to the discussions we have had to date, in which specific plans and details were presented and approved.

The Branding Project to which this letter of agreement refers to, will be managed and conducted by SPG **in addition and unconditionally to its obligations incorporated in the current service agreement**, valid from May 15<sup>th</sup> until August 15<sup>th</sup>, based on a monthly fee of \$50,000.00 USD, which includes the following deliverables:

- Providing government affairs representation and lobbying service before the federal government of the US as well as any other matters mutually agreed upon, on behalf of the Government of the Democratic Republic of Congo ("DRC").
- Advising and consulting strategically to MER and to the DRC representatives about measures and doctrines that advance and strengthen the relationships between the US Government and the DRC Government
- Initiating and advancing a strategic dialogue between the White House through the NSC with the Government of the DRC
- Organizing well prepared educational meetings for the DRC Special Envoy with USG officials, relevant Congressmen and prominent staffers, to advance narrative and messages and to support all efforts against any kind of sanctions initiative, whether through legislative process or executive decree
- Expanding the direct dialogue with the NSC and with the staffers of the leadership of the US, that prepare the ground for a summit meeting in the high level

**Timeline** – The campaign will start on the June 15, 2018 and will conclude on September 15, 2018.

**Fee and expenses** – The agreed upon sum of \$1,250,000 USD is due to SPG via wire transfer of immediately available funds payable in the following installments:

- Thursday, June 14, 2018: MER shall pay SPG \$300,000 USD via wire transfer of immediately available funds;
- Thursday, July 5, 2018: MER shall pay SPG \$500,000 USD via wire transfer of immediately available funds;
- Tuesday, July 10, 2018: MER shall pay SPG \$200,000 USD via wire transfer of immediately available funds; and
- Monday, July 16, 2018: MER shall pay SPG \$250,000 USD via wire transfer of immediately available funds.

**Copyright Infringement and future rights** – SPG will indemnify MER for any payment claim made by 3<sup>rd</sup> party for copyright infringement. SPG agrees that the DRC Government has the full ownership for any material that is produced for the campaign and has full rights for any future usage of the campaign and its part, with no condition to the existence of any engagement between SPG and the DRC and /or MER in any given time

**The Branding Project**

The branding Project is aimed to tell the story of the DRC through a comprehensive public relations effort that engages with the general public, the U.S. business community, the Administration, and Congress

**The "Cobalt Reception"**

SPG will plan and implement a reception during the summer of 2018 on behalf of DRC. All costs of the event, including 3<sup>rd</sup> party expenses, are covered by this comprehensive agreement.
