

Effective June 1, 2025, Paragraph 1 of Appendix B shall be amended to read as follows:


- 1. **Consulting Fee:** For the Services rendered pursuant to this Agreement, the Embassy shall pay Consultant a fixed consulting fee (the "Consulting Fee") of **US\$ 35,000.** per month, payable on the last day of each calendar month during the Term.
