AMENDMENT I TO SERVICE AGREEMENT

This Amendment (the "**Amendment I**"), effective as of August 15, 2026, is made by and between Taipei Economic and Cultural Representative Office in the United States (hereinafter "**TECRO**") with an address at 4201 Wisconsin Ave., N.W., Washington, DC, 20016 U.S.A. and Cornerstone Government Affairs, Inc. (hereinafter referred to as "**Cornerstone**"), a sub-chapter S corporation duly organized under the laws of the District of Columbia, with its principal place of business at 800 Maine Avenue, SW, 7th Floor, Washington, D.C. 20024.

WHEREAS, TECRO and Cornerstone are Parties to Service Agreement with an effective date of February 15, 2026 (the "**Agreement**"); and

WHEREAS, the Parties desire to amend the Agreement as set forth herein;

NOW, THEREFORE, the Parties hereby agree as follows:

1. The term of the Agreement shall be extended for six (6) months, commencing on August 15, 2026 through February 14, 2027 (the "**Term**").
2. Payment for the additional six (6) months shall be made to Cornerstone in six (6) payments of twenty thousand dollars (\$20,000.00) through the Term of the Agreement (the "**Fee**").
3. Except as amended herein, all other terms and conditions of the Agreement remain in full force and effect.
