



Item 8: Describe fully the nature and method of performance of the above indicated agreement or understanding.

This is a partnership agreement between the Rose Lokissim Association and Vanguard Africa to support a US-based advocacy campaign to bolster and accelerate the efforts to free Niger's democratically elected President Mohamed Bazoum and his wife, who have been arbitrarily detained since a military coup in July 2023.

Upon receipt of an invoice, Rose Lokissim Association will transfer to Vanguard Africa \$15,000 on the 15th of each month, beginning on January 15, 2025, and for the next 3 months (through April 15, 2025).
