**CONTRACT FOR SERVICES**

This contract is entered into between the Socialist Party of Albania ("the Client"), Sheshi Austria, 1, Tirana, Albania, and Ballard Partners, Inc. ("the Firm"), 403 East Park Avenue, Tallahassee, FL 32301.

Recitals

Whereas, the Client wishes to retain the services of the Firm in order that the Firm may provide strategic consulting and advocacy services to the Client in connection with its relations with the United States government; and

Whereas, the Firm wishes to provide such representation as the Client may from time to time require; and

Whereas, the parties have agreed to the terms under which the Firm will represent the Client and wish to memorialize their agreement in writing.

Now, therefore, in consideration of the mutual covenants herein contained and intending to be legally bound hereby, the parties agree as follows:

1. Term of Agreement. This agreement shall become effective on April 1, 2017 and shall remain effective until March 31, 2018. On or after September 1, 2017, this agreement may be terminated with thirty (30) days written notice by either party.

2. Duties of The Firm. It shall be the Firm's duty to consult with the Client and advocate on its behalf those issues the Client deems necessary and appropriate before the US Federal government. Issues and objectives may include, but not be limited to, enhancement of US-Albania relations, strengthening of democratic institutions and rule of law, promotion of judicial reform, implementation of joint counterterrorism and military efforts, advance economic growth initiatives and further the integration of Albania into European and Euro-Atlantic structures. It shall further be the Firm's duty to inform the Client of developments in legislation and policy relevant to the Client's issues and objectives.


3. Duties of The Client. It shall be the Client's duty to provide the Firm the information necessary to best represent the Client. It shall also be the Client's duty to timely compensate the Firm for its services.


4. Compensation. The Firm shall receive from the Client \$20,000 a month for this agreement, plus the reasonable costs associated with the representation, including but not limited to, necessary registration fees; and travel expenses such as hotel, air fare, car services and meals, excluding costs typically associated with the operation of an office such as overhead, staff, and equipment. The fee shall be paid in 12 equal installments of \$20,000 a month, beginning April 1,

2017, and continuing to be due on the first of each month until the termination of the agreement.  
The Firm will bill costs monthly.
