The foreign principal is the Government of the Democratic Republic of the Congo. As described in Mer's initial registration statement, Mer was hired by the DRC government to advise it on U.S. policy and political concerns regarding African security and commerce issues and with respect to planning the Special Envoy's engagement in bilateral diplomacy. In furtherance of these services, during this 6 month reporting period, Mer hired and supervised U.S. lobbying and public relations firms. Mer's 3 months initial contract was extended in July 2017 until the end of March 2018 and then was extended again under the same remuneration, until July 2018.


