The foreign principal is the Government of the Democratic Republic of the Congo. As described in Mer's initial registration statement, Mer was hired by the DRC government to advise it on U.S. policy and political concerns regarding African security issues and with respect to planning the Special Envoy's engagement in bilateral diplomacy and commerce relations. In furtherance of these services, during this 6 month reporting period, Mer hired and supervised U.S. lobbying and public relations firms to arrange a branding project aimed to engage with the US business community, the Administration and Congress. Also to organize a special reception event in Washington on the issue of natural resources (focused on cobalt), including all 3rd party expenses. In addition, Mer hired PR firm to highlight the DRC Government efforts to organize free and fair general elections, followed by peaceful transition of power. Mer's 3 months initial contract was extended in July 2017 until the end of March 2018 and extended again until July 2018. On September 14th the DRC Government hired Mer for four months to provide media relations services surrounding the coming elections.
