Registrant has a verbal agreement with Principal to initiate and undertake discussions on behalf of Principal with various members of the United States Congress and persons on their staffs, as well as officials in other appropriate agencies and departments of the U.S. government, and certain non-governmental organizations, concerning the Principal's interest in garnering support for a proposed large-scale development and humanitarian aid plan for Ukraine that resembles aspects of the Marshall Plan (European Recovery Plan).

8. Describe fully the activities the registrant engages in or proposes to engage in on behalf of the above foreign principal.

The foreign Principal believes there are areas of policy and humanitarian assistance that could be of mutual benefit to both Ukraine and the United States. The Registrant will initiate and undertake communications and meetings, where appropriate, with various members of the United States Congress and persons on their staffs, as well as officials in other appropriate agencies and departments of the U.S. government, and certain non-governmental organizations, to explore development and humanitarian aid opportunities of interest to both countries.

At this juncture, all of such communications and meetings involving the Registrant will be in the following forms -- telephone, electronic mail (e-mail), in-person meetings (and personal correspondence in connection with same). No written "informational materials" will be provided to any person with whom Registrant expects to be communicating on behalf of Principal, except copies of Registrant's own earlier prototype development and humanitarian plan, as disclosed as an attachment to Section III (Activities) of his current Registration Statement, dated July 6, 2017.

Registrant anticipates that to some degree his efforts will involve attempting to influence U.S. policy toward Ukraine and the government of Ukraine as concerns providing strategic, diplomatic and/or financial support for a large-scale development and humanitarian aid program for Ukraine, and with reference to the public interests and policies of Ukraine and its government in seeking the assistance of the United States in helping to build such a development and humanitarian program.

Ultimately, Registrant expects to facilitate more direct discussions between U.S. officials and appropriate U.S. agencies, and their counterparts in the government of Ukraine on the subject of development and humanitarian efforts of interest to both countries.
