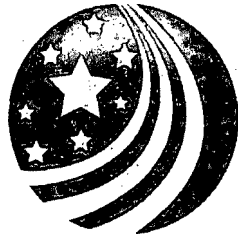

The purpose of this Memorandum of Understanding (MOU) is to set forth the terms of the business relationship between President-elect Felix Tshisekedi of the Democratic Republic of Congo (DRC) and Avenue Strategies Global, LLC (ASG).

ASG will represent the President-elect before the U.S. Executive Branch and Congress. ASG will work to advance the strategic relationship of the President-elect and his government with the United States, support visits of the President-elect and his team to the United States and implement a media and public relations plan to improve understanding of the President-elect and his agenda for the people of the DRC.

For this representation, ASG will file in accordance with the U.S. Foreign Agents Registration Act (FARA) with the U.S. Department of Justice. The cost of these services will be \$90,000 for the period from January 22, 2019 through February 28, 2019, with the option for each party to discuss extending the agreement at any time.
