We are checking on Dr. Sultan's availability and also on Waleed AlMokarrab, the #2 at Mubadala. I wanted to confirm, are you seeking a meeting with Dr. Sultan in his ADNOC role and also with Khaldoun in his Mubadala role? That's where Waleed would come in if he's available.

Separately, can I ask your assistance with Speaker Pelosi's office? I sent [REDACTED] a couple of notes about our Speaker of Parliament/Federal National Council, Dr. Amal AlQubaisi, coming to DC specifically to meet with Speaker Pelosi the first week of May. As you might imagine, we are trying to arrange her visit and would like to secure that meeting if possible. May 2 is the day we are targeting for this meeting.

The UAE recently issued a decree at the end of last year mandating that 50% of our Federal National Council will be comprised of women starting this year. And Dr. AlQubaisi is also the first female Speaker in the GCC (Bahrain followed suit at the end of last year).

Your help here would be greatly appreciated.

[REDACTED] I've gotten the go ahead to schedule a senior staff meeting for Dr. Gargash on the House side. The one key request is to keep it small (7 people max). I know you mentioned Thursday might be a possibility. Would 12:30-2 work on Thursday, 4/11?
